

#### Everything you need to successfully complete your annual review

Your Annual Review is your opportunity to keep pace with the ever-changing environment in which you work:

- The world of child protection and adult safeguarding changes so much in a year, including huge updates to the key guidance, Keeping Children Safe In Education (which now applies to everybody in state education and academies who work with 16 to 19 year olds)
- Your organisation changes. People leave, new people arrive, people change roles. What you offer changes. And your marketing, outreach and on-site events change.
- The national and global context within which you are working changes (especially recently)

Your policies and procedures need to reflect this.

#### **Ofsted Compliance**

If you are delivering degree level apprenticeships or are newly caught by the statutory guidance, Keeping Children Safe in Education, then you have to comply with the Ofsted Framework for Inspection.

If you get this wrong, you can lose your ability to run degree apprenticeships or if you're in education up to 19 you may lose your ability to onboard or enrol future students.

Towards the end of 2020, Ampleforth College lost their ability to enrol students because of failures and safeguarding and KPMG lost their ability to run degree apprenticeships because they didn't have proper safeguarding practices in place.

#### How your Annual Review is supported

I'll help you successfully complete your Annual Review with:

- 1 Training videos to walk you through a step-by-step approach to completing the review in your organisation. This training is designed for HE/FE organisations.
- 2 An easy-to-use Audit Checklist which links your practices and policies with the Safeguarding Association Charter to help you go beyond legal obligations, and implement safeguarding best practice.
- 3 As part of the programme you get access to me via 1-1 video call to talk through the Annual Review work you've done so far, and get any help you need.

# Refresher Training For Designated Safeguarding Leads

Keeping Children Safe in Education makes it a statutory requirement for Safeguarding Leads to complete regular refresher training.

This one day course is designed for Safeguarding Leads who are working with teenagers and young adults. All our case studies and review examples are around young adults aged 15+.

The signs are different when you're working with teenagers and young adults than they are for 0-5 and 5-11 year olds.

We'll cover the key signs that a young person is in trouble or is at risk of harm from one of the multitude of areas that affect them, including sexual harassment, radicalization, mental health, suicidal ideation and self-harm.

The course is available online as pre-recorded videos, or you can choose to book into the Virtual Live Training which is offered quarterly.



# Informal Supervision for Designated Safeguarding Leads

Supervision is not yet a requirement under Keeping Children Safe in Education.

However, your Designated Safeguarding Leads are carrying a huge emotional load, and they need a safe, confidential space to share and process their experiences, and express concerns.

Good Safeguarding Leads are worth their weight in gold, but without the right support they can burn out quickly, so although this informal supervision is not a legal requirement, it certainly is best practice.

As members of the hub your DSL will get access to:

Monthly 30 minute 1-1 Consultations - Your DSL can pick a time and date that suits them, and use this meeting as informal supervision or to discuss issues where they would like individual support or guidance. This time with me is completely confidential.



Twice Weekly Safeguarding Clinics - Every Tuesday and Thursday morning, I'm available in my Zoom room between 10.30am and 12pm (London time). DSLs can drop in if they have a query or would like to talk with other DSLs.

#### **The Safeguarding Association Charter**

The Charter reflects the legal and moral safeguarding obligations of HE/FE organisations.

It aligns with the requirements of Ofsted, Keeping Children Safe in Education and The Office For Students.

Membership of the Charter is a clear demonstration of your organisation's commitment to the safety and well-being of your students.


